
Symposium 26

The MGSA's 26th biennial Symposium was held at the California State University, Sacramento, from November 7-10, 2019. Katerina Lagos, Professor of History and Director of the CSUS Hellenic Studies Program, hosted the event and welcomed our members to the Hyatt Regency Hotel. The conference featured 29 academic panels, 4 special sessions, a meeting with the editorial team of the *Journal of Modern Greek Studies*, and a mixer for graduates students in our field.

The keynote event featured two eminent speakers, Professors Artemis Leontis (University of Michigan) & Antonis Liakos (Kapodistrian National University of Athens). The theme they addressed was "Modern Greek Studies in the 21st Century: Views from History and Literature."

MGSA President Franklin Hess on the establishment of the Founders' Endowment for the MGSA Symposium.

"Tonight, I would like to announce the creation of a new fundraising campaign, the Founders' Endowment for the MGSA Symposium. Since I hosted the Symposium in Bloomington in 2013 on what was essentially a shoe-string budget, the three subsequent Symposia—Atlanta, Stockton, and now Sacramento—have raised the bar considerably. We are now providing catered lunches as well as catered coffee breaks. And, in addition to travel grants for graduate students, which have been in place since Indiana, we are now, through Katerina Lagos' initiative, supporting the travel of scholars from Greece and elsewhere in Europe. This is something that I expect will be a one-time event for the foreseeable future and that will mark the Sacramento Symposium as a truly unique event.

These amenities and stipends—to which we are rapidly becoming accustomed—have largely been provided thanks to the generosity of donors: some are national organizations like Johns Hopkins University Press and the National Hellenic Society. Most, however, are local. While hosting the Symposium is an honor and an opportunity to put your program on the map, I and the other members of the Executive Board believe that programs should not have to pay a financial penalty to host the Symposium. The resources that are going to support our biennial meeting could be put to other uses: improving facilities and collections and endowing scholarships and professorships. For that reason we voted at the last Executive Board Meeting to inaugurate a new fundraising campaign: the Founders' Endowment for the MGSA Symposium. The goal of this campaigned is to raise \$250,000 to make the Symposium economically self-sufficient. With a 5% rate of return, this endowment will yield approximately \$25,000 every two years to help offset the expense of hosting the Symposium. This will allow us to do a variety of things such as: keep registration fees down, increase graduate student stipends, inaugurate permanent travel stipends, reduce fundraising pressures for the Local Arrangements Committee, etc. Most importantly, it will allow the Symposium to remain an important venue for academic free speech.

The Founders' Endowment will honor the Founding Members of the MGSA: people like Edmund Keeley, John Iatrides, Lily Macrakis, John Petropoulos, Thomas Doulis, and Peter Bien. This is a very partial list. There are so many who have contributed to our shared endeavors. While the founders were not always without controversy, I think the we can agree that we are indebted to the vision and initiative that they showed in creating the MGSA. Putting the Symposium on solid financial footing is a proper tribute to their memory."

Nominations for Executive Board Elections

This is a call for MGSA members to nominate candidates for the MGSA's next Executive Board, which will assume its duties at the Fall 2020 board meeting for a three-year term.

Current members should send their nomination(s) to the Chair of the Nominations Committee, <u>Katerina Lagos</u> no later than February 22, 2020. Please consider the candidate's investment in the MGSA's goals and initiatives and his or her ability to work actively with others toward these ends.

For nomination of regular EB members, Article IV.7.g. of the MGSA Constitution states:

Any regular or student member may nominate a member of the Association for election to the Executive Board. If the chair of the Nominations Committee receives, not later than April 1, four or more letters nominating the same candidate, that candidate shall have equal standing with those nominated by the Nominations Committee. [Because of time constraints this year, please send nominations before February 22]

For nomination of the graduate student representative on the EB, Resolution 2/10 states:

(...) Any graduate student at a Doctoral Program in the United States or Canada, who is pursuing a Ph.D. in any aspect of Modern Greek Studies and who is a member of the Association in good standing can be nominated or self-nominated for the position of Graduate Student Representative to the Executive Board; such nomination shall be accompanied by a nominating statement and a letter from the student's advisor stating the standing of the graduate student in the Program and the student's project.

For complete details on the mandated procedures, refer to <u>Article IV</u>, 6-7 of the MGSA's Constitution.

MGSA Greek Language Pedagogy Workshop

The MGSA Greek Language Pedagogy Workshop is a biennial event offering a working weekend on university-level Greek language instruction focused on a select topic or approach to language pedagogy. The MGSA's Undergraduate Studies Committee determines the subject and presenters of each workshop, which is free and open to the public. Past topics have included the instrumentalist aspects of language, the alignment of Greek instruction with national and European standards, skills-building, and Content Based Instruction (CBI), an approach that integrates academic subject matter within the context of second or foreign-language instruction. The 8th biennial Greek Language Pedagogy Workshop took place at Columbia University in 2018 and the topic was "The Future of Modern Greek Language and Teaching in Higher Education in the US: Opportunities and Challenges."

The 9th biennial Greek Language Pedagogy Workshop will be devoted to the topic of "Language and Content: Resources, Materials and Sound Practices for Teaching and Learning Modern Greek." The workshop will take place at Indiana University, Bloomington, Indiana, from November 6-8, 2020. In addition to receiving support from the MGSA, the 2020 workshop will benefit from the local support of the Institute for European Studies and the Modern Greek Program at Indiana University Bloomington. In January, the organizing committee will invite proposals for the workshop sessions of Saturday, November 8. Topics may include: evaluation of existing materials and approaches/methods; project-based and community-based learning; teaching with technology; inclusive teaching, etc.

The workshop is designed for those engaged in language pedagogy as an instructor/researcher with a commitment to (Modern Greek) language/ literature/ culture instruction at the tertiary level; as well as those developing the undergraduate curriculum of Modern Greek Studies and/or directing a Modern Greek program or a study abroad program. Do place the 2020 workshop on your schedule and take advantage of its offerings. Make this and future workshops an occasion for learning (and sharing) through practice. If you have a pedagogy or curriculum question or wish to incorporate Greek in other classroom modules and want to learn how to do this better in the company of others, please talk to the prior workshop host(s) to see how your concerns can be addressed in this or subsequent workshops. If you are interested in hosting a Pedagogy Workshop, please contact Elsa Amanatidou, Chair of the MGSA Undergraduate Studies Committee. The organizer's home institution receives a \$1,000 grant from the MGSA to defray the costs of hosting.

MGSA Fund for Innovative Initiatives

This fund, for innovative initiatives in Modern Greek Studies, provides monetary support to institutions of higher learning and other professional organizations to support conferences, workshops, and other activities that promote Modern Greek Studies (including those of the Greek diaspora). Granted on a competitive basis, up to five grants will be awarded per academic year, each for a maximum award of \$500. An institution may receive an award once every three years. Applications for support of individual activities will not be supported.

Ergon: Greek/American Arts and Letters

Ergon: Greek/American Arts and Letters, the online journal in Greek/American and Greek Transnational Studies is a recipient of three-year start-up support from the MGSA (2018-2020).

The MGSA notes Dan Georgakas's recognition in the *National Herald* of *Ergon* and the support it enjoys from the MGSA:

"... Poetry has always played a central role in Greek culture. Since the

end of World War II, Greece has produced two Nobel laureates and a dozen Nobel nominees. In the United States, the sparsity of Greek-oriented literary journals has made it difficult to establish a literary community. Some defunct journals that tried to meet that need include *Coffeehouse*, *Mondo Greco*, *Aegean Review*, and *Voices*. Two years ago, that tradition was revived by the creation of *Ergon* magazine.

Yiorgos Anagnostou, *Ergon*'s editor, considers Hellenic culture to be a multi-lane, two-way highway complex connecting diverse regions, not a one-way street of translated homeland exports. With that perspective, Ergon publishes poetry, fiction, translations, interviews, and literary essays. Initial funding for the creation of this lively forum involved grants from the Modern Greek Studies Association and Ohio State University. *Ergon* is available gratis. The projects I have described respect and honor our past achievements, but they believe a culture that wishes to endure and prosper must grapple with the givens of the present rather than being immersed in the past. In that sense, they do not advocate for Hellenic culture, they are Hellenic culture. Anyone who desires a culturally viable Greek America can consider them and similar initiatives as guides for what can be done in the here and now."

Journal of Modern Greek Studies: From the Editors

The *Journal of Modern Greek Studies*, published by Johns Hopkins University Press, is the semi-annual flagship journal of the MGSA. On January 1, 2019, the Journal was passed on to two new editors, Johanna Hanink (Arts & Humanities) and Antonis Ellinas (Social & Behavioral Sciences). New Associate Editors Nektaria Klapaki (Arts & Humanities) and Olga Demetriou (Social & Behavioral Studies) have joined the staff as well. Book Review Editors Kostis Kourelis and Katerina Lagos are continuing.

We are happy to report that the JMGS now utilizes an online submissions platform that offers increased transparency to the review process because authors can now track the progress of their articles through that process. Please find the platform here.


